Privacy notice - Information pursuant to Articles 13 and 14 of EU Regulation 2016/679 of the European Parliament and of the Council of 27 April 2016 (General Data Protection Regulation)

WAITING LIST PURCHASE NFT year 2022

Dear Sir / Madam The EU General Data Protection Regulation 2016/679 recognises and regulates the right to the protection of personal data, while respecting your fundamental rights and freedoms and your personal dignity.

This notice contains information on the processing of personal data, also special categories of personal data and judicial data, carried out by Autodromo Nazionale Monza SIAS S.p.A., for pre-contractual and contractual activities relating to the communications of one or more NFT sales campaigns in the year 2022.

I. DATA CONTROLLER AND DATA PROTECTION OFFICER

a) Data Controller (hereinafter referred to as "the Controller")

II. PURPOSE AND LEGAL BASIS OF THE PROCESSING

Autodromo Nazionale Monza SIAS S.p.A. will process your personal data (e-mail address) for the following purpose:

1. sending one or more "exclusive" communications containing all the necessary information in order to purchase of NFT in the year 2022.

Legal basis

The data processing is legitimate for the purpose:

Art. 6 paragraph I letter b) of EU Regulation 2016/679 "*processing is necessary for the performance of a contract to which the data subject is party or in order to take steps at the request of the data subject prior to entering into a contract;*"

Specifically, the processing is carried out for the activities of sending "exclusive" communications containing the information necessary for the purchase of NFT in the year 2022 (privileged access to NFT sales, promotional activities, information on purchase methods, facilities and benefits).

III. HOW YOUR PERSONAL DATA ARE PROCESSED

Your personal data collected for the pre-contractual and contractual activity as detailed above, will be processed in compliance with the provisions of the Regulations, by means of manual, computerised and telematic tools, with logic strictly related to the purposes already explained, in a lawful and fair manner, as well as in compliance with the principle of minimisation, collected exclusively for the purposes indicated in this privacy notice or provided for by law, regulations or EU legislation or, for the fulfilment of necessary and essential purposes in the performance of the activity performed and/or requested.

The data collected by the Data Controller will be processed by staff duly authorised and instructed by the Data Controller itself, and will be stored in a suitable and appropriate place, protecting their confidentiality, in compliance with official secrecy.

In order to carry out certain activities, the Data Controller may engage external suppliers, who will be appointed "data processors" pursuant to Article 28 of EU Regulation 2016/679, who will carry out specific processing operations necessary to guarantee the Company's services, within the limits of the the purposes listed above.

In this case, the data will also be processed by:

Rocket Dreams S.r.l., (owner of the brand NFactory) with registered office in Milan, Viale Corsica 42, C.F. and P.IVA 12223150967, previously appointed as "external controller" pursuant to art. 28 of EU Regulation 2016/679, which is entrusted with the task of maintaining the website and the collection of e-mail addresses.

We also inform you that no automated decision-making, including profiling, are carried out and that your personal data will not be transferred to third countries.

IV. COMMUNICATION OF DATA

The Company may only disclose your data to those entities to whom it is required to be disclosed by the law.

We inform you that the personal data will not be disclosed unless provided for by a regulation, nor will it be further disclosed to others without your explicit request.

V. DATA RETENTION PERIOD

Your personal data will be stored for the period of time provided by the applicable legislation.

The data controller will retain the data (e-mail address) until December 31, 2022 for the purposes listed above; thereafter, , the data will be deleted, destroyed or simply kept anonymous.

VI. NATURE OF THE PROVISION

The provision of your personal data is mandatory for the management of pre-contractual and contractual procedures by the Company and any refusal to provide such data would make it impossible to manage the relationship and the performance of the institutional tasks of the Company.

VII. YOUR RIGHTS

You may exercise your rights at any time, in accordance with the terms and conditions set out therein, as provided for in Articles 15 (Right of access of the data subject), 16 (Right of rectification), 17 (Right to erasure or right to be forgotten), 18 (Right to restriction of processing), 20 (Right to data portability).

Data subjects may exercise their rights by contacting SIAS, the Data Controller, or the Data Protection Officer, at the contacts indicated in point I of this privacy notice.

Data subjects who believe that the processing of their personal data carried out by the Company is in breach of the provisions of the Regulation have the right to lodge a complaint with the Supervisory Authority, as provided for by article 77 of the Regulation, or the right to obtain judicial remedy (article 79 of the Regulation).
