

GENERAL REGULATION



- PEOPLE AND VEHICLES ADMITTED MUST BE RESPECTFUL OF STRUCTURES/FACILITIES,
 THE FLOWER BEDS AND ALL THE GREEN AREAS, AND MUST NOT ENTER FENCES OR
 DEMARCATIONS IN WHICH THEY ARE NOT ALLOWED;
- AVOID CONDUCT THAT MAY CAUSE DAMAGE AND/OR INJURY TO SELF OR PRESENT STAFF;
- RESPECT TRAFFIC RULES AND EXISTING PROHIBITIONS, CONFORM TO THE DISPOSITIONS ISSUED BY CIRCUIT AND CONTROL STAFF;
- VIEW THE PROCEDURES AND EMERGENCY PATHWAYS THAT ARE AVAILABLE ON THE STANDS, AND INSIDE CIRCUIT BUILDINGS;
- RESPECT THE EXISTING SIGNAGE AND THE INSTRUCTIONS ISSUED BY STAFF, IN ORDER TO AVOID HARM AND/OR INJURIES;
- RESPECT NO-ENTRY SIGNAGE IN AREAS AND FACILITIES RESTRICTED TO AUTHORIZED STAFF;
- ACCESS IS STRICTLY FORBIDDEN FOR CHILDREN UNDER 14 YEARS UNACCOMPAINED BY ADULTS;
- ACCESS TO TRACK AND PIT-LANE IS STRICTLY FORBIDDEN TO CHILDREN UNDER 18 YEARS OLD WITHOUT SPECIFIC AUTHORISATION;
- ANIMAL ACCESS IS ONLY ALLOWED ACCORDING TO LAW;
- INSIDE THE CIRCUIT THE SPEED LIMIT IS 30 KM/H ON INTERNAL ROAD ACCESS AND AT WALKING PACE IN AREAS WITH ACTIVITIES AND/OR PUBLIC; PARKING AND STOPPING IS FORBIDDEN INSIDE UNDERPASSES AND OVERPASSES TO VEHICLES AND PEDESTRIANS;
- THE USE OF MOTORCYCLES AND SCOOTERS IS PERMITTED ONLY WITH HOMOLOGATED HELMET;
- WHOEVER SPOTS A DANGEROUS SITUATION IS REQUIRED TO WARN AND REPORT THE EVENT TO SERVICE STAFF, TO THE CALL CENTER 039/24821 OR TO THE CHECK POINT 039/2482241;
- IN CASE OF EVACUATION OF BUILDINGS; STANDS OR OUTDOOR AREAS, FOLLOW THE EMERGENCY PATHWAYS EASILY DETECTABLE THROUGH THE DEDICATED SIGNALS; AND FOLLOW THE POSSIBLE INDICATIONS ISSUED BY EMERGENCY TEAM OPERATORS;
- IT IS STRICTLY FORBIDDEN TO USE FLAMES, GAS STOVES, IF NOT PREVENTIVELY AUTHORIZATION;
- IN CASE OF NEED OF ELETTRIC, WATER OR OTHER SUPPLY, AN AUTHORIZATION IS NEEDED BY SIAS S.P.A. AND ALL OF THE NECESSARY PRECAUTIONS MUST BE IMPLEMENTED;
- IN RELATION TO SCHEDULED EVENTS THERE MAY BE NOISE, DUST, COLLISION AND RUN OVER HAZARDS, ALL USERS MUST BE EXTREMELY CAREFUL;
- IT IS STRICTLY FORBIDDEN TO LEAVE WASTE;
